From academic year 2024-25, Pune, the institute **Seri International School, (S. N. B. P. English Medium School)** Group no. 93/2, Autade Handewadi, Dist. An application was submitted for starting a new school on self-financing basis, Pune (Primary to Higher Secondary, ST.1 to ST.12, All Branches, English Medium, CBSE).

2. With regard to your application on the subject mentioned above, you are hereby informed that under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 and the Maharashtra Self-Financed Schools (Establishment and Regulation) Rules, 2020 from the academic year 2024-25, C.B

S.E. Affiliated Subhadra Education and Research Centre, Autade Handewadi, Tt. Haveli, Dist. PUNE MANAGED SERI INTERNATIONAL SCHOOL, (SNBP ENGLISH MEDIUM SCHOOL) GROUP NO. 93/2, Autade Handewadi, Distt. Pune (Primary to Higher Secondary, 1st to 12th, All Branches, English Medium, CBSE) to start a self-financed school on a self-financed basis by giving letter of intent to start the work of the said school with the following terms and conditions is coming

3. Terms and Conditions:

- Compliance with the provisions of the said letter of intent, the Act and the rules made thereunder
- Unless done, does not guarantee letter of approval. (ii) On the basis of the said letter of intent, the registered institution or trust or company shall not start schools / upgradation classes.
- of the said Letter of Intent, CBSE/ ICSE/ IGCSE. / I.B., etc. cannot be used as a non-revocation certificate for affiliation of boards.
- within 18 months from the receipt of the letter of intent by the registered institution or trust or company, as prescribed in the Right of Children to Free and Compulsory Education Act, 2009 and the Maharashtra Right to Free and Compulsory Education of Children Rules, 2011 and the directions issued by the Government from time to time under the Act and the Rules; . compliance with standards, terms and

conditions regarding infrastructure and physical facilities (such as classrooms, toilets, drinking water facilities, principal and staff classrooms, libraries, laboratories, etc.) will be mandatory

(v) After complying with the above-mentioned facilities, it shall be the responsibility of the institution or trust or company to submit an application for letter of recognition to the area level authority of the concerned district within 18 months of receipt of the letter of intent.

(vi) If within 18 months, the school management fails to submit an application for a letter of recognition, the letter of intent shall stand cancelled. The period of Letter of Intent cannot be extended under any circumstances.

(vii) After the letter of intent has been issued, the location of the proposed school cannot be changed. If the management has applied for a letter of approval from a place other than the place approved by the Government,

(viii) Letter of Intent will be cancelled. (8) The State Government may, at any time, cancel the letter of intent on the ground of breach of any of the provisions of this Act or of the rules made thereunder or failure to comply with any directions issued under the Act or standards or standards or terms and conditions specified by the Government from time to time.

(ix) The said institution or trust or company shall be required to deposit the amount specified in "Schedule C" of the Act, jointly in favor of the management and the concerned educational authority (secondary), in the form of National Savings Certificate or in the form of fixed deposit in any nationalized bank.

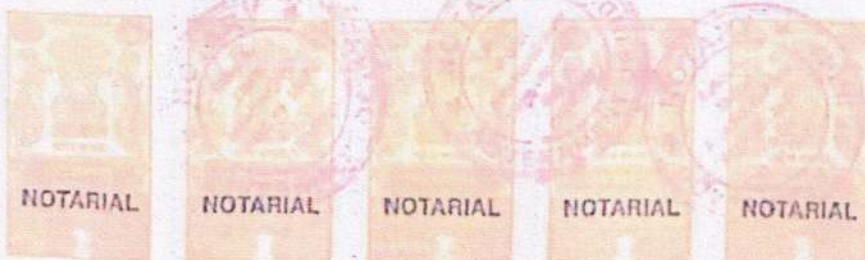



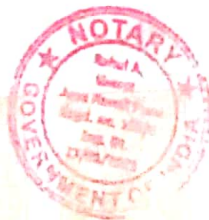
